Are you thinking of becoming a medical marijuana patient in Montana? It's very simple: Follow these easy steps

WHERE DO I GO??

Go to a physician for a quick visit to obtain your recommendation? Aren't sure where to find a Doc? We frequently recommend Dr. Hedgyes at Wellness Solutions Montana. His website is wellness solutions mt. com, and schedule yourself an appointment:

WHAT DO I NEED TO BRING??

Copy of MT Driver's License, MT State ID, or MT Tribal ID. For minor cardholder applicants, a copy of MT Driver's License, MT State ID, or MT Tribal ID of legal guardian.

WHAT CONDITIONS MAKE ME ELIGIBLE??

- Cancer, glaucoma or positive status for human immunodeficiency virus, or acquired immune deficiency syndrome when the condition or disease results in symptoms that seriously and adversely affect the patient's health status.
- Cachexia or wasting syndrome
- Severe chronic pain that is persistent pain of severe intensity that significantly interferes with daily activities as documented by the patient's treating physician
- Intractable nausea or vomiting
- Epilepsy or an intractable seizure disorder
- Multiple sclerosis
- Crohn's disease
- Painful peripheral neuropathy

- A central nervous system disorder resulting in chronic, painful spasticity or muscle spasms
- Admittance into hospice care
- Post-traumatic stress disorder (PTSD)

**The cost may vary at different physician's office, but it is usually between \$130 - \$150 dollars.

WHAT NEXT?

Now you need to submit your Physicians Statement to the Montana State Health Department for Approval.

Have your ID handy! You will have to take a picture of your ID and a photo of yourself to complete the application. *The Photo of yourself cannot include sunglasses or a hat*.

- 1. Visit https://mt-public.mycomplia.com/#!/signin
- 2. Register (in the upper right hand corner, there is a 'Register Button'
 - a. Follow the steps for the registrations, and you will receive an email for confirmation
- 3. After you confirm you account, you can log in!!
- 4. Once in the portal, select 'new application' from the left hand menu
 - a. Then, select 'New Patient Registration'.
 - b. Complete Each section of the application, and after each page, click 'save and next' to ensure your info is saved in case of any problems!
 - **c**. The section labled 'Documents' is where you have to submit photos of your ID, the photo of yourself, and photos of your Physician Statement.
 - We suggest taking these photos and emailing them to yourself, saving them to your desktop and then downloading them into the Documents section.
- 5. Complete the Application by clicking pay and submit, at which time you can enter your credit or debit card information (the fee to the state is \$30.00).

Congrats!! You're Done!!

Now all you have to do is wait for the state to receive and accept your application. This usually takes 7-14 days, although with COVID19, wait times have been longer!
